

# <u>412 – Peer Discussion Review</u>

With Steven Bruce and Claire Short

#### 1. Introduction

- The discussion was between Steven and Claire about Claire's Peer Discussion Review, an essential component of osteopathic Continuing Professional Development (CPD).
- Steven emphasized the **informal nature** of the discussion, dressing casually to contrast with traditional CPD presentations.
- Claire expressed **initial anxiety** about completing the review, feeling overwhelmed by the form and uncertain about whether she would "get it right."

#### 2. Purpose and Requirements of the Peer Discussion Review

- The **General Osteopathic Council (GOsC)** requires osteopaths to complete a Peer Discussion Review every **three years** as part of their CPD cycle.
- The review ensures osteopaths:
  - Engage in objective learning activities.
  - Reflect on their practice.
  - Maintain their professional standards.
- Unlike **chiropractic CPD**, which is submitted **annually**, osteopaths must complete this structured peer discussion at the end of their three-year cycle.

## 3. Addressing Anxiety and Misconceptions About the Review

- Claire initially feared that completing the form incorrectly could lead to **serious consequences**, such as professional scrutiny.
- Steven reassured her that:
  - The GOsC is not trying to catch practitioners out.
  - The form is not submitted to the GOsC unless specifically requested, but should be kept on record.

- Minor mistakes are not punished unless they involve **deliberate dishonesty**.
- The review is meant to be a **constructive**, **reflective** process rather than a **high-stakes examination**.

# 4. Choosing a Peer for the Discussion

- The **peer** for the discussion does not have to be an osteopath.
- Acceptable professionals include:
  - Doctors, midwives, chiropractors, and physiotherapists.
  - **Practitioners who are not statutorily registered**, such as massage therapists, are unlikely to be accepted.
- Peers **review the osteopath's CPD records**, discuss their learning experiences, and provide feedback.
- Claire's peer for this review was Steven.

# 5. Key Sections of the Peer Discussion Review Form

- Standard 1: CPD Across All Four Themes
  - Osteopaths must complete CPD activities covering the four Osteopathic Practice Standards (OPS) themes:
    - 1. Communication & Patient Partnership
    - 2. Knowledge, Skills & Performance
    - 3. Safety & Quality in Practice
    - 4. Professionalism
  - Claire provided examples of CPD activities that met these themes, including discussions on consent, communication, patient care, and clinical knowledge.
- Standard 2: Objective Activity Requirement
  - Osteopaths must complete at least **one objective activity** involving **feedback** and **reflection**.
  - Acceptable objective activities include:
    - Case-based discussions (CBDs)

- Clinic audits
- Peer observations
- Claire used a case-based discussion (CBD), involving a case encountered by a physiotherapist in her clinic, demonstrating that the case didn't have to be one of her own patients.
- Standard 3: Ensuring CPD Benefits Patients
  - Osteopaths should show that their CPD leads to improvements in patient care.
  - Claire's CPD activities, especially discussions around communication, consent, and ethics, directly contributed to better patient interactions.
- Standard 4: Maintaining CPD Records
  - Osteopaths must keep a **detailed record** of their CPD activities.
  - Claire's CPD portfolio (managed by APM) provided comprehensive documentation, including certificates with reflections and mapped OPS themes.

## 6. Reflection and Action Plan

- Claire needed to identify any areas for further development.
- While **no major gaps** were found, she **chose to include a personal goal** of **attending more dissections** in the next CPD cycle.
- The action plan does not need to be strictly followed but demonstrates engagement with professional development.
- 7. Practical Advice for Osteopaths Completing Their Peer Discussion Review
  - Start early don't leave it until the last minute.
  - Choose a peer you trust, as the discussion is meant to be supportive.
  - Use available resources, such as structured CPD records from APM, to make the process easier.
  - Don't overcomplicate it the GOsC is not looking for perfect essays, just evidence of engagement and reflection.

• A structured CPD portfolio (such as the one provided by APM) makes meeting the requirements much simpler.

## 8. Conclusion

- The Peer Discussion Review should not be a source of stress.
- It is designed to be a helpful and reflective conversation, not a test or an audit.
- Having structured CPD records and attending **regular case-based discussions** makes the process much easier.
- Osteopaths should view the review as **an opportunity for self-improvement** rather than an obligation.
